**AMENDMENT TO  
INMATE TELEPHONE SERVICE AGREEMENT**

~~August 21~~ <sup>Sept</sup> THIS AMENDMENT TO INMATE TELEPHONE SERVICE AGREEMENT dated August 21, 2010 ("Amendment"), amends and revises that certain Inmate Telephone Service Agreement (the "Agreement"), dated October 1, 2007 by and between **Lewis County Sheriff**, with an address at 360 N.W. North Street, MS: SHE01, Chehalis, WA 98565 ("Premise Provider"), and **Global Tel\*Link Corporation**, a Delaware corporation having its principal place of business at 2609 Cameron Street, Mobile, AL 36607 ("Company").

**WHEREAS**, Company provides inmate telephone services to the Lewis County Sheriff; and

Company and Premise Provider hereby agree to amend and extend the Agreement as follows:


- 1) In accordance with Section 1. Term of the Agreement, the Parties mutually agree to activate a three (3) year renewal term commencing on January 26, 2011 and running through January 25, 2014.
- 2) In accordance with Section 4. Compensation of the Agreement, the Parties mutually agree to adjust the commission rate to the County from the current rate of thirty-six (36%) to forty-one (41%) of the gross revenue billed or prepaid for all phones covered by this Agreement. The commission increase shall be effective immediately upon signature by both parties to this Amendment.
- 3) In accordance with Section 5. Rates of the Agreement, the Parties mutually agree to adjust the Local Call rate from the current \$2.00 flat fee to \$2.75 flat fee plus SBF and any regulatory fees per call. The Local Call rate increase shall be effective immediately upon signature by both parties to this Amendment.
- 4) Upon acceptance and implementation of the adjusted local call rate as referenced above, **Netcard** shall be added as a calling option for the county with the same rates as collect and advance pay calls.

Except as set forth above, there is no other revision or amendment to the Agreement or the obligations of Company and Premise Provider, and the Agreement remains in full force and effect.
