**Amended Contract Language:**

Attachment CC (BAFO) Section 7: Provision of JPAY Inmate Mail (to be implemented at no cost to the State and at the time selected by the State); please indicate all applicable fees. No outbound electronic Inmate Mail service will be implemented, and there will be no implementation/deployment of inmate kiosks under this contract. Section 7 is modified to provide new voice mail services to inmates and their families.

Commission of \$0.50 per voice mail paid to the Department on a quarterly basis.


