

9. This Amendment serves to recognize and acknowledge the following. All other terms and conditions of the contract remain unchanged.

- A. Add the following contract language: The FCC ordered Rate Caps for all interstate calling effective February 11, 2014. Due to the FCC Rate Cap order a revised rate for calls from Alaska DOC Institutions will go into effect on February 11, 2014. There will be a \$3.75 flat rate charge (plus taxes) per 15 minute call to interstate and intrastate collect calls (\$.25 per minute collect rate) and a \$3.15 flat rate charge (plus taxes) per 15 minute call for interstate and intrastate debit/pre-paid calls ( \$.21 per minute debit/prepaid rate). Effective February 11, 2014, no commission shall be paid on revenues earned through the completion of interstate calls for any call type received from the Contract.
- B. Add the following contract language: Securus will provide an automated message quoting the cost of the flat rate charge for intrastate and interstate for both collect calls and debit/pre-paid calls prior to connecting the call.
- C. Add the following contract language: Johnnie Wallace will be the Operations point of contact for DOC Institutions. The phone number is 907-761-5623.
- D. Add the following contract language: Alaska DOC will provide Securus an updated private call list for the Alaska Bar Association, Alaska Public Defender Agency's, Office of Public Advocacy, Disability Law, PREA and Ombudsman twice a year during the months of February and August. Securus will enter the private call lists into the inmate call control system at all Alaska DOC Institutions.
