

  - The term of this Agreement, which was approved on October 29, 2004, is clarified to read: "The term of this Agreement is: Four (4) years, from February 1, 2005 through January 31, 2009. The performance of work under this Agreement shall commence on February 1, 2005 and shall continue through January 31, 2009. The State shall have the option to extend this Agreement for two (2) additional one (1) year periods."
  - Attachment 2 - Special Provisions, Section 6. Concession Payments, the following is added to the 3rd paragraph: "The required concession payments and monthly management reporting shall commence with the April 2005 revenue month and continue through the term of the Agreement."
  - The rates and charges set forth in Attachment 7-A Pricing Workbook to Contractor's proposal shall be effective as of April 1, 2005.


This amendment is effective as of February 1, 2005.  
All other terms and conditions shall remain the same.



