1. Pursuant to and in accordance with the Uniform Terms and Conditions, Paragraph 5 Contract Changes, Subsection 5.1 Amendments, and Paragraph 2.5 Severability, this contract is hereby amended. The parties' express purpose in this amendment is to comply with certain changes in the law governing inmate telephone service without changing the fundamental nature of this contract any more than is necessary. The parties acknowledge that there will likely be future changes to the governing law either by further actions of the Federal Communications Commission ("FCC") or by the U.S. Court of Appeals for the District of Columbia Circuit or other courts of competent jurisdiction.
2. Pursuant to WC Docket 12-375, FCC 15-136, and U.S. Court of Appeals for the D.C. Circuit Order dated March 7, 2016 in Case No. 15-1461 (consolidated), surcharges per call for the Inmate Telephone Service will be eliminated effective March 17, 2016. In addition, the new per minute rates will become effective March 17, 2016 until further notice as listed below:
