## FOURTEENTH AMENDMENT TO CONTRACT FOR INMATE TELEPHONE SERVICES

THIS FOURTEENTH AMENDMENT ("Amendment") to the contract for Inmate Telephone Services originally entered into on May 3, 2001 ("Original Agreement") is entered into as of the date it has been fully executed by the parties to this Amendment, by and between the Georgia Department of Corrections ("Department"), an agency of the State of Georgia, and Global Tel\*Link Corporation ("Contractor"), the assignee of "MCI WorldCom Communications, Inc." d/b/a/ Verizon Business, a company duly authorized by law to transact business in the State of Georgia.

The purpose of this Amendment is to modify the interstate calling rates as required by the Federal Communications Commission (FCC) Docket No. 12-375.

NOW, THEREFORE, in consideration of these premises and the mutual promises and agreements hereinafter set forth, the parties hereby agree as follows:

- 1. Except as otherwise expressly set forth herein, the terms and conditions continued in the Original Agreement, as modified by the First, Second, Third, Fourth, Fifth, Sixth, Seventh, Eighth, Ninth, Tenth, Eleventh, Twelfth, and Thirteenth Amendments are unchanged. The Agreement, including all amendments shall be referred to as the "Agreement." All capitalized terms used in this Amendment and not expressly defined herein shall have the respective meanings given to such terms in the Agreement.
- 2. The Department and Contractor hereby agree to modify the Collect and AdvancePay interstate calling rates commencing on February 6, 2014. All other calling rates will remain unchanged. The calling rates shall be as follows:
