Dear Sheriff DeTrollo:

I am your Global Tel*Link Corporation (GTL) Western Region Account Manager. As you may be aware, there have been many changes in this industry over the past several years. One in particular that occurred over four years ago was GTL's acquisition of AT&T's National Public Market's group. As a result of this acquisition, GTL is still providing your county with its long distance (LD) services for your inmate telephone system. The change in ownership has likely been so transparent to you, jail staff, offenders and their friends and families that the switch may not have even been noticed. Rest assured though, in addition to providing LD services, we are a sole source provider recognized as the industry leader in inmate telephone system products and services.

That brings me to the business at hand. Many years ago, Grant County Sheriff's Office entered into a LD contract with AT&T for the provisioning of LD calls by offenders on your inmate telephone system. That contract expired some years ago and has been in an "auto-roll mode" ever since. GTL is currently in the process of streamlining the account documentation associated with its former AT&T accounts. Your local service provider, FSH, recently extended the local and intraLata contract with your county to 09/30/2010. In order to align the provision of all the components that comprise your service, GTL is enclosing a LD contract that mirrors the expiration date of your local and intraLata service agreement. This way, if you ever decide to take your inmate services out to bid both contracts would expire on the same date, making it far easier on the county and any potential suppliers.

The enclosed LD agreement has no effect on the terms and conditions you enjoy under the existing LD contract originally entered with AT&T; it merely makes the expiration date coincide with the expiration date of your inmate phone service provider contract.

Please have this agreement signed by an authorized representative of the County and return to me. We will return a countersigned copy for your records. If you have any questions or concerns, please let me know.

First Amendment to Long Distance Inmate Telephone Service Agreement

This First Amendment ("First Amendment"), effective as of the date of the second signature on the First Amendment ("Effective Date"), to that certain long distance inmate telephone service agreement, dated May 29, 1998 (the "Agreement"), by and between **Global Tel*Link Corporation ("GTL")**, as assignee and successor in interest to AT&T, and Grant County Sheriff's Office (the "County"), hereby amends and revises that Agreement as follows:

WHEREAS, County desires, and GTL agrees, to have GTL remain as the exclusive provider of Long Distance service and be the primary carrier for operator assisted ("0+") InterLATA and Interstate calls placed from inmate telephones at the County's Correctional Facilities; and

WHEREAS, County is currently under a contract for local and IntraLATA services with FSH Communications, Inc. (the "FSH Contract"),

THIS FIRST AMENDMENT amends and revises the Agreement to provide for an expiration date that is the same expiration date as that of the FSH Contract for the purpose of ensuring the continuity of local, IntraLATA, InterLATA and Interstate service.

Except as set forth above, there is no other revision or amendment to the Agreement or the obligations of County and GTL, and the Agreement remains in full force and effect.
