EMBARQ Payphone Services Inc. (EPSI) presents the following Rates and Commissions for the Nevada Department of Corrections (NDOC). EPSI will provide a variety of Commission offers for NDOC consideration. Following are descriptions of the (6) financial options contained in Attachment J:

Section I

Option #1, Base Rates with no part-time administrators Embarq offers NDOC **commission of 53.5%** on gross revenues. Embarq offers NDOC a **MAG Payment of \$1,847,385**

Option #2, Lower Rates with no part-time administrators Embarq offers NDOC 43.5% Commission on gross revenues Embarq offers NDOC a MAG Payment of \$1,425,543 See attachment J for table of lower rates

Option #3, Higher Rates with no part-time administrators Embarq offers NDOC 56.2% Commission on gross revenues Embarq offers NDOC a MAG Payment of \$2,257,171 See attachment J for table of higher rates

Option #1, Base Rates with three part-time administrators Embard offers NDOC **commission of 51.5%** on gross revenues Embard offers NDOC a **MAG Payment of \$1,778,324**

Option #2, Lower Rates with three part-time administrators Embarq offers NDOC 41.5% Commission on gross revenues Embarq offers NDOC a MAG Payment of \$1,360,001 See attachment J for table of lower rates

Option #3, Higher Rates with three part-time administrators Embarq offers NDOC 54.2% Commission on gross revenues Embarq offers NDOC a MAG Payment of \$2,148,731 See attachment J for table of higher rates

Additional notes:

- No billing recovery fees will be added to any called party's phone bill by EMBARQ or any of its subcontractors.
- Commissions will be paid on total gross revenue, with no deductions for fraud, bad debt, or uncollectible charges.
- EMBARQ will pay commission on every type of payment method (collect, debit (calling cards), and prepaid), without exception.
- Minimum Annual Guarantees (MAGs) would be payable at the end of each effective year of the contract; i.e. monthly commission payments would be made on actual gross revenues with a 'true-up' occurring if the total actual commission payments during that year were below the proposed MAG.
