**AMENDMENT**

This Amendment is made and entered into as of April 12, 2012 ("Effective Date") by and between the County of Cook, a public body corporate of the State of Illinois, on behalf of the Cook County Bureau of Technology hereinafter referred to as "County" and Securus Technologies, a corporation authorized to do business in the of the State of Illinois hereinafter referred to as "Consultant".

**RECITALS**

**WHEREAS**, the County and Consultant have heretofore entered into an Agreement approved by the County Board on May 28, 2008 (hereinafter referred to as the "Agreement"), wherein the Consultant is to perform Coinless Inmate and Public Pay Telephone Equipment & Services; and

**WHEREAS**, scope modifications are necessary to provide Prepaid Calling Cards to the County as an additional temporary service as outlined in Exhibit A; and

**WHEREAS**, the scope modifications will not require an increase to the contract.

**NOW THEREFORE**, in consideration of the provisions and conditions set forth in the Agreement, the parties hereto do mutually agree to amend the Agreement as hereinafter set forth.

It is further agreed by and between the parties hereto that the sole modifications of, changes in and amendments to the agreement are as follows:

## EXHIBIT A

### SCOPE MODIFICATION

Contract Number 08-45-256

Coinless Inmate and Public Pay Telephone Equipment and Services Contract

#### Additional Scope of Services

Pending activation of debit accounts at the County Facilities during a trial period not to exceed six (6) months, Consultant will provide the County, upon receipt of the County's written request, with inmate Prepaid Calling Cards for resale to inmates ("Purchasers") at County Facilities.

Consultant will invoice the County the face value for each order of Prepaid Calling Cards less 57.5%, plus any applicable sales tax and shipping charges. Securus shall not impose a higher rate on calls made by Purchaser than is currently in effect under the Contract, as amended.

In order to process the resale of the Cards to inmates, Consultant will provide a voice mail system and a speed dial number (800#) to our voice mail system where Consultant will accept and record inmate orders for Prepaid Calling Cards. Consultant will then provide County on a weekly basis a report of all such orders. In the event that County elects to fulfill the orders, Consultant will provide the County Sherriff's Office with an additional 4% discount off of the face value of the Cards.

Prepaid Calling Cards are not returnable or refundable; all sales are final. However, each Prepaid Calling Card will become the property of the Purchaser and can be used on any phone. Each Prepaid Calling Card will be valid for no more than six (6) months from the date it is first used. The cards are subject to applicable local, state, and federal taxes, plus any applicable per call surcharge fee. The calling rates for the Prepaid Calling Cards are reflected in the attached Rate Sheet.

#### Invoicing

County agrees to pay the invoices, including all applicable sales taxes and other regulatory charges, within thirty (30) days after the invoice date. All applicable sales taxes will be charged on the face value of the Prepaid Calling Cards sold, unless County provides Consultant a valid reseller's certificate before the time of sale.

#### Continuation of Services beyond Trial Period

If County elects to continue with the sale of Prepaid Calling Cards beyond such six-month trial period, then County and Consultant will mutually agree in writing to extend the Contract by one (1) additional six (6) month period or enter into an Amendment to the Contract to provide for the ongoing sale of Prepaid Calling Cards.
